Directions to Turning Stone Resort Casino – Verona, NY

The Oneida Indian Nation’s Turning Stone Resort Casino is located about 30 miles east of Syracuse at NYS Thruway Exit 33.

From Syracuse

Take I-90 (NYS Thruway) East to Exit 33 (Verona). Turn left onto Route 365. Turn left onto Patrick Rd/County Hwy-48A. The Resort is on the left.

From Albany, NY and Points East

Take I-90 (NYS Thruway) West to Exit 33 (Verona); Turn left onto Route 365. Turn left onto Patrick Rd/County Hwy-48A. The Resort is on the left.

From Binghamton, NY and Points South

Take I-81 North to Exit 16A; Take I-481 North to Exit 6; Take I-90 (NYS Thruway) East to Exit 33 (Verona). Turn left onto Route 365. Turn left onto Patrick Rd/County Hwy-48A. The Resort is on the left.

From Watertown, NY and Points North

Take I-81 South; Take I-481 South; Take I-90 (NYS Thruway) East to Exit 33 (Verona). Turn left onto Route 365. Turn left onto Patrick Rd/County Hwy-48A. The Resort is on the left.

From Buffalo, NY and Points West
